**NOTICE OF PROPERTY TAX DELINQUENCY  
AND IMPENDING DEFAULT**

Made pursuant to Section 3351 and 3352, Revenue and Taxation Code

I, DAN McALLISTER, San Diego County Treasurer-Tax Collector, State of California, certify as follows:

That at 12:01 a.m. on July 1, 2018, by operation of law, any real property (unless previously tax-defaulted and not redeemed) that have any delinquent taxes, assessments or other charges levied for the fiscal year 2017-2018, and/or any delinquent supplemental taxes levied prior to the fiscal year 2017-2018, shall be declared tax-defaulted.

That, if declared tax-defaulted, the real property may be redeemed by payment in full of the amount of defaulted taxes together with such additional redemption penalties and fees as prescribed by law, or under an installment plan of redemption.

That, if the real property taxes remain unpaid after five years, or three years if a nuisance abatement lien has been recorded, the property will be sold at tax sale, unless an installment plan of redemption is initiated and maintained.

That a detailed list of all properties remaining tax-defaulted at the close of business on June 30, 2018, and not redeemed prior to being submitted for publication, shall be published on or before September 8, 2021.
