**NOTICE OF PUBLIC INTERNET AUCTION ON July 20-25, 2018**  
**OF TAX-DEFAULTED PROPERTY FOR DELINQUENT TAXES**  
**Made pursuant to Section 3692, Revenue and Taxation Code**

On February 13, 2018, I, Dan McAllister, San Diego County Treasurer-Tax Collector, was directed to conduct a public auction sale by the Board of Supervisors of San Diego County, California. As authorized by the County Board of Supervisors, and pursuant to California Revenue and Taxation Code Section 3692(e), the properties offered at the online auction are being re-offered within 90 days of Public Auction Property Tax Sale 7067, which was held Friday, May 4, 2018 through Wednesday May 9, 2018. The tax-defaulted properties listed below are subject to the Treasurer-Tax Collector's power of sale and have been approved for sale by a resolution dated February 13, 2018 of the San Diego County Board of Supervisors.

The sale will be conducted at <https://www.sdttc.mytaxsale.com> Friday, July 20, 2018, 8:00a.m. (PST) through Wednesday, July 25, 2018, closing times vary, as a public auction to the highest bidder for not less than the minimum bid as shown on this notice. Due diligence research is incumbent on the bidder as all properties are sold as is. The winning bidder is legally obligated to purchase the item.

There is free computer access at public libraries located throughout the County. The County and its employees are not liable for the failure of any electronic equipment that may prevent a person from participating in the sale.

Registration on the website is free, a \$1,000.00 advance bid deposit, and a non-refundable \$35.00 bid deposit processing fee, is required of each bidder prior to bidding on any property that is part of this internet auction. The deposit payment shall be made via an electronic debit (ACH debit) to Grant Street Group at <https://sdttc.mytaxsale.com> starting on June 18, 2018 at 9:00 a.m. Pacific Time. In order to participate in this tax auction, all bid deposit payments shall be received by Grant Street Group no later than 5:00 p.m., Pacific Time, on July 12, 2018. Registration is not permitted through the mail and will not be permitted after this date. Full payment and deed information indicating how title should be vested is required within five (5) business days after the end of the sale. Only the following forms of payment shall be accepted: certified or cashier's check (made payable to SDTTC); cash (paid at the San Diego branch office); or wire transfer. Transfer taxes will be added to and collected with the purchase price. The right of redemption will revive for any property purchased by a credit transaction if payment in full is not received within five (5) business days after the end of the sale.

The right of redemption will cease at the close of business on Thursday, July 19, 2018 at 5:00p.m. (PST) and parcels not redeemed will be offered for sale.

If the parcel is not sold, the right of redemption will revive and continue up to the close of business on the last business day prior to the next scheduled sale.

In the event the tax-defaulted parcel identified below is in a bankruptcy proceeding and subject to the automatic stay provisions set forth at 11 U.S.C. 362 the Tax Collector will not offer the parcel for sale at a tax sale or public auction; if relief from the stay is obtained before the sale date and statutory requirements have been met, the parcel may be offered for sale as scheduled.

If the properties are sold, parties of interest as defined in California Revenue and Taxation Code Section 4675, have a right to file a claim with the county for any excess proceeds from the sale. Excess proceeds are the amount of the highest bid in excess of the liens and costs of the sale that are paid from the sale. Notice will be given to parties of interest, pursuant to law, if excess proceeds result from the sale.
