APRIL 10th PROPERTY TAX DEADLINE IS FAST APPROACHING!

Pay Early and Avoid the Long Lines

San Diego, CA... San Diego County Treasurer-Tax Collector Dan McAllister today reminded San Diego County taxpayers that the last day to pay the second installment of their 2014-15 property taxes without penalty is **Friday, April 10, 2015.**

“Our branch offices are all ready to serve our taxpayers,” said McAllister. “As a reminder, the Downtown San Diego branch is the only office that will accept cash. Credit card payments are accepted online and by phone. To avoid credit card fees, pay online through our website via e-check. Pay early and avoid the long lines.”

As a convenience to taxpayers, all five branch offices will offer extended hours on **Friday, April 10th, from 7:00 am – 7:00 pm.** Please note, paying by e-check on our website IS NOT the same as paying through your bank’s online banking system. Payments that are submitted through your bank may take up to ten business days before our office receives payment. PLEASE confirm dates with your bank before scheduling, to avoid penalties. Alternatively, please consider paying by e-check on our website at www.sdtreastax.com – it’s free, fast & easy and your payment is credited as of the date of “submission”.

In September, 984,587 tax bills were mailed to San Diego County property owners. The 2014-2015 property tax bills are expected to generate \$5.08 billion. To date, only 35% of second installment charges have been paid and approximately 550,000 installments remain unpaid, for a total of \$1.64 billion.

Property tax bill payments are due in two equal installments: November 1st and delinquent after December 10, 2014, and February 1st and delinquent after April 10, 2015. Second installment late payments are automatically assessed a 10% penalty, plus a \$10 fee.
