QUARTERLY REPORT OF CANNABIS TAX FY 2024/25

Attached please find the third quarter report for Cannabis Tax revenue collected.

The total Cannabis Tax collections through the third quarter of the fiscal year 2024/25 are \$138,292.87. This equates to 138.29% of the budgeted revenue of \$100,000.00 for the 2024/25 fiscal year. The third quarter report encompasses outstanding taxes, penalties, and interest.

On November 8, 2022, San Diego County voters approved Measure A, which was established to fund general County purposes including but not limited to parks, fire safety, roads, health, and social equity, by taxing cannabis businesses in the unincorporated area.

The San Diego County Treasurer-Tax Collector is responsible for the administration and collection of cannabis tax for establishments located in the unincorporated areas of the County. For establishments located within an incorporated city, cannabis tax is collected by the City in which the establishment is located.
