NOTICE OF TAX DEFAULT (DELINQUENT) LIST
Made Pursuant to Section 3371 Revenue and Taxation Code

I, Dan McAllister, San Diego County Treasurer-Tax Collector, State of California, certify that: Notice is hereby given that the real properties listed below were declared to be in tax default at 12:01 a.m. on July 1, 2007, by operation of law. The declaration of default was due to non-payment of the total amount due for the taxes, assessments and other charges levied in 2006-07 that were a lien on the listed real property.

Tax-defaulted real property may be redeemed by payment of all unpaid taxes and assessments, together with the additional penalties and fees, as prescribed by law, or it may be redeemed under an installment plan of redemption.

The amount to redeem, including all penalties and fees as of September 2010 is shown opposite the parcel number and next to the name of the assessee.

If the taxes remain unpaid after July 1, 2012, the property will be subject to sale at public auction. Property upon which a nuisance abatement lien has been recorded, and a city, county, city and county, or non-profit organization requests the property be offered at the next public auction, shall be subject to the Treasurer-Tax Collector's power to sell if the taxes remain unpaid after June 30, 2012
