**NOTICE OF PUBLIC AUCTION TAX SALE ON MARCH 24, 2015
OF PROPERTY THAT HAS BEEN TAX -DEFAULTED FOR FIVE OR MORE
YEARS**

Made pursuant to Section 3692, Revenue and Taxation Code

On December 2, 2014, I, Dan McAllister, San Diego County Treasurer-Tax Collector, was directed to conduct a public auction tax sale by the Board of Supervisors of San Diego County, California. The tax-defaulted properties listed below are subject to the Treasurer-Tax Collector's power of sale and have been approved for sale by a resolution dated December 2, 2014 of the San Diego County Board of Supervisors.

The tax sale will be conducted at **9:00 A.M. on Tuesday, March 24, 2015** at the **San Diego Convention Center, located at 111 West Harbor Drive, "Ballroom 20A", San Diego, CA 92101** as a public oral auction to the highest bidder for cash in lawful money of the United States, for not less than the minimum bid as shown in this notice. If no bids are received on a parcel, it may, at the Treasurer-Tax Collector's discretion, be re-offered within a 90-day period or at the next scheduled sale, at a minimum price determined appropriate to stimulate competitive bidding. Anyone wishing to bid on parcels offered at the sale is required to register at one of our office locations by Friday, March 20, 2015, complete a Deed Information Sheet and pay a non-refundable fee of \$50.00. The Final Day for Bidder Registration is **Friday, March 20, 2015.**

By law, the right of redemption ceases on **Monday, March 23, 2015 at 5:00 p.m. (Pacific Time)** and properties not redeemed or withdrawn from the sale will be offered at the sale. If a parcel does not sell, the right of redemption revives up to the close of business of the last business day prior to the next scheduled sale.

If a property does sell, parties of interest, as defined in California Revenue and Taxation Code Section 4675, have a right to file a claim with the county for any excess proceeds that may result from the sale. Excess proceeds is the amount of proceeds resulting from the sale of the property that is more than \$150.00 in excess of the taxes and assessment liens, fees and costs of the sale which are paid from the sale price. Notice will be given to parties of interest, pursuant to law, if excess proceeds result from the sale.
