**NOTICE OF 2025-26 PROPERTY TAXES DUE**

Made pursuant to § 2609, Revenue and Taxation Code

San Diego County Treasurer-Tax Collector hereby announces that regular secured tax bills will be mailed on or before November 1, 2025, to all property owners at the addresses shown on the tax roll. If you own property in San Diego County, the county listed in this notice, and do not receive a tax bill by November 1<sup>st</sup>, contact the Tax Collector's office at [sdttc.com](http://sdttc.com) to view and pay your bill, or call 1-855-829-3773 to pay your bill by phone. For information call 1-877-829-4732. A duplicate of your tax bill may be obtained for a fee of \$1.00, or you may view your property information online at [sdttc.com](http://sdttc.com) at no additional cost.

The **FIRST INSTALLMENT** of 2025-2026 taxes is due and payable on November 1, 2025, and will become delinquent if not paid by 5 p.m., or the close of business, whichever is later, on December 10, 2025; thereafter, a 10% penalty will be added.

The **SECOND INSTALLMENT** is due on February 1, 2026, and will become delinquent if not paid by 5 p.m., or the close of business, whichever is later, on April 10, 2026; thereafter a 10% penalty will be added plus the cost to prepare the delinquent tax records and to give notice of delinquency.

If December 10<sup>th</sup> or April 10<sup>th</sup> falls on a Saturday, Sunday or a legal holiday, the time of delinquency will be the next business day at the close of business, or 5:00 p.m. (Pacific Time).

**BOTH INSTALLMENTS MAY BE PAID** when the first installment is due.

**FAILURE TO RECEIVE A TAX BILL DOES NOT RELIEVE THE TAXPAYER OF THE RESPONSIBILITY TO MAKE TIMELY PAYMENTS.** To avoid late penalties, payments must be postmarked or electronically transacted (at [sdttc.com](http://sdttc.com)) by the delinquent date.
