QUARTERLY REPORT OF TRANSIENT OCCUPANCY (TOT) Final Annual Report REPORT FY 2021/2022

Attached please find the final annual report for Transient Occupancy Tax (TOT) revenue collected.

The total TOT collections through the fourth quarter of the fiscal year 2021/2022 are \$7,225,923.25. This equates to 150.88% of the budgeted revenue of \$4,789,263.00 for the 2021/2022 fiscal year.

Effective January 15, 2022, Supervisorial District boundaries were adjusted by the County of San Diego Independent Redistricting Commission.

The following tax rate areas have been reassigned or partially moved into two or more districts, Del Mar, El Cajon, Escondido, Julian, La Mesa, Ramona, Rancho Santa Fe, and Spring Valley. The Treasurer-Tax Collector values its role in supporting the County of San Diego's strategic plans and operational goals for the benefit of our citizens.
